FY21-41321: 65 Gallons Automated Curbside Trash and Recycling Cart Regulation

On April 20, 2021 the Board of Health voted unanimously to adopt the following trash regulation and fee schedule and will be dedicated to reinforcing:


All legal dwellings with an address on a Town accepted public roadway will receive one (1) sixty-five (65) gallon cart for household solid waste as well as one (1) sixty-five (65) gallon cart for recyclables that must be used for West Newbury automated curbside collections. Town issued carts (with Town Seal) are the property of the Town of West Newbury and are assigned to West Newbury households. Any trash or recycling in excess of the one (1) sixty-five gallon designated cart issued by the Town will be the responsibility of the property owner to dispose of properly.

Mattresses and box springs are banned from disposal or incineration.


Purpose: In order to ensure that waste materials, are disposed of in an environmentally responsible manner, these regulations are intended to provide for the systematic collection of trash and recyclables. Additionally, these regulations promote recycling, compliance with state-mandated waste bans, and assist in cost reduction of residential trash disposal by diverting those items from the waste stream that can be managed more effectively.

Note: Regulation FY21-41321 will supersede Regulation FY02-121002.

FEES FOR ADDITIONAL CARTS-

12 month permits run with fiscal years July 1st - June 30


Additional Carts - trash or recycling..... \$100.00

Trash Sticker for additional cart (annual fee)..... \$120.00
If purchased after July 1, price will be pro-rated. (\$10/mo.)

Bulk Item Sticker (up to 25 pounds)..... \$20.00
Items over 25 pounds will require two stickers.

BULKY ITEM INFORMATION AND SCHEDULE

Beginning June 1st, 2021 –

To arrange for a bulky item collection appointment and purchase a bulky item sticker, please call 978-363-1100 ext 141.

Bulky items that weigh up to 25 pounds require 1 sticker.

Bulky items that weigh 25 pounds and less than 50 pounds require 2 stickers.

Bulky items sticker fee \$20 per sticker.

Stickers need to be attached to item curbside, or they will not be collected.

Mattresses and box springs are prohibited from curbside collection. We have teamed up with the City of Newburyport and are offering a recycling program at the Colby Farm Lane Recycling Center. Please call in advance to make drop off arrangements 978-465-4410 ext 1.

Items weighing over 50 pounds will need to be pre-approved by calling 978-363-1100 extension 141; item may possibly require a special collection at the cost of the owner of the item.

One item only per collection per household, per scheduled date.

Collections will be scheduled for the same day as your regularly scheduled trash/recycling day during the first week of the following months, **August, October, December, February, April and June.**

Bulky item collections will follow the holiday schedule.
